### Please describe your Fencing Experience & BF Service:

I have been a fencing parent for the last 9 years in the United Kingdom and the United States. This creates a unique experience of living grass roots and international fencing through their respective governing bodies and programmes.

I have also taken up the sport personally as a veteran in the past year, competing the 2022 and 2023.

Lastly, I have applied my technical background to create the UK Ratings system. The UK Ratings system's two-year trial programme is aimed at increasing the number of appropriate level competitions for British Fencing members at all levels, providing extra incentives to compete benefitting fencers, clubs and coaches. The first D, E, U event based on UK Ratings ran directly after an Open with excellent results: 23 fencers competed, including 11 that did not compete in the Open, and brought the organiser an additional £1,000 in gross revenues. Upon the pilot's success, we plan to extend to Epee and Sabre.
